- to be aware that any violations of the Institute's Corruption Prevention Policy and the reporting requirements outlined in the previous point may result in the termination of the existing contractual relationship, under the applicable regulations;



- to be aware that the sponsorship amount offered guarantees the right to benefits, as outlined in the "Table of Opportunities" available in the public notice;
- to be aware that if due to organisational reasons that have arisen and/or of another nature, or due to intervening legislative or regulatory requirements, the event cannot be carried out, the proposed sponsorship may be allocated to support other activities, subject to prior notice and consensus of the proposer;
- to undertake not to behave in any way that may be detrimental to the image or name of the sponsee;
